The erection of any sign or billboard within the Town of Hector, which is rented or used to advertise a product, service or establishment which is not the principal product, service or establishment found on the property containing the sign or billboard, is hereby prohibited.

The Hector Town Board, with the advice of the Town's Planning Board, may in its sound discretion, and in the best interests of the Town, grant exceptions to this Local Law upon written application of the property owner.

For any and every violation of the provisions of this Local Law, the owner of the property on which the sign or billboard is located and/or the owner of the sign or billboard, shall be held liable on conviction thereof for a fine or penalty of not less than fifty dollars (\$50.00), nor more than two hundred fifty dollars (\$250.00) for each and every offense. Each week of continued violation shall constitute a separate additional offense.

This Local Law shall take effect immediately upon filing with the Secretary of State.
